Then follow instructions and send a payment from your wallet to our cryptocurrency address.

CAN I HAVE MULTIPLE, SIMULTANEOUS DEPOSITS?

You can make multiple deposits. The number of deposits that you can have at same time is unlimited. Each of your subsequent deposit will bring additional accrual. Note that each of your deposits will be separate with its own terms of accruals.

HOW FAST IS THE DEPOSIT CREDITED?

HOW OFTEN IS THE PROFIT ACCRUED?

Your profit accrued depending on your chosen investment plan – every 24 hours within certain period or once at the end of this period.
